Measures of Establishment of Faculty Evaluation Committee NCTU College of Engineering

- 第一條 本學院依據本校組織規程第三十六條設置『工學院教師評審委員會設置辦法』(以下簡稱「院教評會」)。
- Article 1 In accordance with Article 36 of Rules for the Organizations of the University, the College herein establishes "Measures for the Establishment of Faculty Evaluation Committee" (hereinafter termed as the FEC of the College).
- 第二條 院教評會之職責為評審有關本院專、兼任教師聘任資格及等級、升等、停聘、解聘、進修、 休假、延退及退休等事項。評審時依相關評審辦法處理。
- Article 2 The Committee's duties and responsibilities are the evaluations of(re)appointment, promotion, suspense of employment, termination of contract, dismissal, advanced studies, sabbatical, contract extension and retirement of full-time and part-time teachers of the College. Each evaluation shall follow related measures of evaluation.
- 第三條 本委員會委員由本學院教師中依每八人推選一人之比例組成(不滿八人者加一人)。各系所分配之名額由院教評會決定,委員由各系、所推選。院長為當然召集人。
- Article 3 Every commissioner of this committee shall be elected by every eight teachers of the College (if the rest of the teachers' number is less than eight, then one commissioner can be elected from them). The quota of commissioners from each department and graduate institute shall be allocated by the FEC, and each commissioner shall be elected by each department/graduate institute. The dean of the College shall be the ex-officio convener.
- 第四條 院教評會委員之資格為已獲教育部教授證書,且在最近三年內曾發表國際學術性期刊 文。院教評會委員得依其學域推薦適當之校內外升等著作審查人選並提供意見供院教評會參 考。最後之著作審查委員名單由院長圈選。
- Article 4 FEC commissioners' qualification is to have the certificate of professorship issued by Ministry of Education, and to have published international academic journal paper(s) in the recent 3 years. FEC commissioners may recommend eligible candidates of reviewers from the University or external institutes according to their research field and offer opinions for recommendation to the FEC for reference. The final list of the publication reviewers shall be determined by the dean of the College.
- 第五條 院教評會委員之任期為一年,每學年度九月中旬改選組成之。委員連選得連任兩次。
- Article 5 The tenure for each FEC commissioner is one year, and commissioners shall be re-elected in mid-September every academic year. A commissioner can be re-elected for the second term.
- 第六條 院教評會委員在評審升等案時若不克出席,不得行使投票權。
- Article 6 If any commissioner of the FEC fails to attend the meeting of evaluating the application for teacher promotion, he/she shall not exercise the right to vote.
- 第七條 本設置辦法經院務會議通過並送校教師評審會核備後實施,修正時亦同。
- Article 7 The Measures of Establishment have been approved by the Meeting of College Affairs, and shall be implemented after being submitted to the FEC of the University for review. All amendments shall follow the same procedures as above.
